Verification of High School Graduation

The State Board of Nursing (and most other health career programs) requires that students provide official documentation of high school graduation or equivalent before beginning programs.

Documentation must be opened by a HACC official. Student copies of high school records or diplomas are NOT acceptable.

TRANSFER OF CREDIT FROM FOREIGN EDUCATIONAL INSTITUTIONS

Transcripts from foreign educational institutions must be requested by the student and be sent directly to one of the following credential evaluation services before they can be reviewed at the Registrar's office for transfer credit. We request that a course-by-course evaluation be completed so that we can view the U.S. grade and credit equivalencies for transfer. Once the evaluation service completes the evaluation, they should send an official transcript directly to HACC:
